CONSERVATION PERIOD

The data retention period is: Data will be processed for as long as necessary to pursue the current commercial relationship and for the next ten years from their acquisition date.

RIGHTS OF THE INTERESTED PARTY

3. Pursuant to European Regulation 679/2016 (GDPR) and national legislation, the interested party may, in accordance with the procedures and within the limits established by current legislation, exercise the following rights:
- request confirmation of the existence of personal data concerning him / her (right of access);
 - to know its origin;
 - receive intelligible communication;
 - to have information about the logic, the methods and the purposes of the processing;
 - request the updating, rectification, integration, cancellation, transformation into anonymous form, blocking of data processed in violation of the law, including those no longer necessary for the pursuit of the purposes for which they were collected;
 - right to limitation or opposition to the processing of data concerning him;
 - right of revocation;
 - right to data portability;
 - in cases of consent-based processing, to receive their data provided to the holder, in a structured and readable form by a data processor and in a format commonly used by an electronic device;
 - the right to lodge a complaint with the Supervisory Authority.
